From time to time, there will be updates to this Privacy Policy ("PP"). At the top of this page you find the version date. It is your responsibility to check our PP. By using our Services, you consent to our PP.

Beeckon by Entourage SA complies with the provisions of the Data Protection Act (RGPD)

- 1) We do not use the data of our users for any commercial purpose.
- 2) We define the purpose and respect the rights of people.
- 3) We check the relevance of the data.
- 4) We limit the retention of data.
- 5) We secure data in Switzerland (infomaniak).
- 6) We do not sell personal data, we do not subcontract the data.

All users have the right to access, correct, oppose or delete their data on their personal profil. By deleting their Beeckon account all related data and information is automatically and immediately deleted.

Beeckon follow the 6 principles recommended by RGPD for protection of personal data:

1. Notice - data subjects should be given notice when their data is being collected,
2. Purpose - data should only be used for the purpose stated and not for any other purposes,
3. Consent - data should not be disclosed without the data subject's consent,
4. Security - collected data should be kept secure from any potential abuses,
5. Disclosure - data subjects should be informed as to who is collecting their data,
6. Access - data subjects should be allowed to access their data and make corrections to any inaccurate data,
7. Legal - data subjects should have a method available to them to hold data collectors accountable for not following the above principles.

beeckon collects information about you both directly (you updating your profile information or adding knowledge, for example) and indirectly (for instance, we will record the user activities on the site. We will do this in order to see where users have some difficulties and subsequently to determine where we have improvement opportunities. The recordings and all personal identifiable information will be deleted as soon as we have taken note of essential improvements needed. The notes will not cover any

personal identifiable information - only details needed for the below Purpose.

We collect your information in order to be able to provide the best services we can to you and other members.

## 3. Consent

By using our Services, you consent to us collecting and using your information to enhance our Services to you and other members.

## 4. Security

We are doing what we can to keep your data safe with us, but like all other information and services on internet, we can never give a 100% guarantee.

## 5. Disclosure

The data we collect can be stored on the servers we use (all based in Switzerland infomaniak), but also on your local device using mechanisms such as browser web storage, application data caches, cookies and similar technologies.
